The bid must include the completed bid form located at the end of this document. Bids must be submitted in a sealed envelope, clearly marked **BID 2016-002 Tractor** on the outside of the envelope.

Bids will be publicly opened, in the Vermilion County Board office at **11: a.m. on Friday, October 21, 2016.** In the case of a tie or where the bid amount is the same between two bids, then the bids will be considered based on receipt, as noted on the sealed envelope when received by the County Board office.

Bids will be publicly opened, read aloud and shall be open for public inspection in the Vermilion County Board office for a period of at least forty-eight (48) hours before an award of the contract is made
