RE: AMENDMENT TO THE COMBINED ANNUAL BUDGET AND APPROPRIATION ORDINANCE FOR THE LAW LIBRARY FUND

WHEREAS, the Capital Improvement Fund is used to pay for the initial installation and maintenance of a case management computer system for the various departments in the courthouse; and

WHEREAS, the County Departments involved will collectively share in the purchase and payment of the system and maintenance and it is desirable to set up a capital improvements project line to support these expenditures and an initial balance needs to be placed in the fund from various other sources thereby requiring budget amendments, each separately stated for each fund in a series of budget amendments; and
